### JUNIOR GOLF FOUNDATION OF AMERICA PROGRAMMING APPLICATION FORM

**PROGRAM REGISTRATION:** *Pre- Payment options:* Applications must be filled out with form of payment - cash, check (made out to PBC-BOCC) or credit card.  
**CHECK IN:** Location: Junior tent by the starter's booth. *Sign in procedure:* Parent must sign-in and receive number assignment which will match their child's name tag. The child will then go to the waiting area with their golf bags and sit in their assigned chair until instructor assignments. On the first day of class parents will receive course guidelines and course materials.

**EQUIPMENT:** Clubs and balls will be provided for those children who need equipment.

**ORIENTATION:** A first time participant child with their parents must attend orientation on the first day of a new level. *When:* Starts 15 minutes into the first session. Where: Junior tent by the starters booth

**PICK-UP:** *Location:* Pavilion (near club house). At the end of the class each child will be seated in their assigned chairs until each parent signs-out. Parents must arrive at the pick-area 10minutes before the end of class.

### Junior & Parent Conduct Guidelines

I understand the following will **NOT** be tolerated:

- Conduct detrimental to Golf Professional Services, Inc., Palm Beach County facilities or the JGFA
- Use of alcohol or illegal drugs or gambling
- Abusive language or profanity
- Displays of temper involving throwing or slamming equipment
- Abuse of club facilities
- Poor golf etiquette and cheating
- Use of golf carts, unless the players are being shuttled between holes, or at the discretion of officials
- Breach of the USGA rules of golf

In Addition:

- Parents must arrive 10 minutes before the start and end of each program
- Follow check in and pick up procedures

Any breach of the above guidelines on conduct will result in:

Full Refund: Cancel 7 days prior to start of class or doctor's note

Full Credit for future program: Cancel 2 days prior to start of class

No refunds: 1 day prior to start of class and once class as started.
